## WHEREAS:

1. The Shiprock Chapter of the Navajo Nation acts on this resolution pursuant to the authority conferred upon the Chapter through Navajo Nation Code Title 26, Chapter 1, Section 1, Part B, which states, "Through adoption of this Act, the Navajo Nation Council delegates to Chapters' governmental authority with respect to local matters consistent with Navajo Law, including custom and tradition;"; and

2. Pursuant to 26 N.N.C. Section 1 (B) Shiprock Chapter is vested with the authority to review all matters affecting the community and to make appropriate corrections when necessary and make recommendations to the Navajo Nation and other local agencies for appropriate actions; and

3. The Shiprock Chapter has the fiduciary responsibilities according to the Chapter's FMS, Fiscal Policies. The Chapter is required to provide their financial reports to the Chapter membership on a monthly basis in compliance with 26 N.N.C.§ 1001 and the FY2025 Budget Instructions Manual and the Chapter's Five Management System; and

4. The Shiprock Chapter has provided the 3 financial statements for the month ending July 31, 2025 to the community, the Statement of Revenues and Expenditures, Combining Balance Sheet and the Budget to Actual Report. These reports are attached as Exhibit "A." **NOW THEREFORE BE IT RESOLVED:**
